Determination of Quorum

Streets

The sidewalk grant is half million dollars, and the Towns part is \$130,000.00, which we already have this set to side in a CD. This will put sidewalks up Hwy 200 to the Locust Town limits.

Parks & Recreation

We did receive the PARTF grant in the amount of \$212,500.00. We are so excited about this. A list has been approved as to how the money will be spent.

Planning & Zoning
