Public Comment

Peter Asciutto- 1. He would like for Stanly County to budget \$100,000.00 in 2021-22 for the 10 municipalities to use for capital improvements, equipment, repairs. Basically, this is more for upkeep of parks, equipment, facilities rather than for programming, payroll. We can fine tune the parameters if we decide to approve this. 2. Commit to this program for a one-year trial. At next years' budget meeting we can evaluate the grant program to see if this is something to continue in 2022-23 with changes or to keep it as a one-year commitment. 3. Each of the ten municipalities would have the opportunity to apply for up to a \$10,000.00 50/50 matching grant. If this passed, we would have to fine tune the details, such as creating the grant process, application deadlines, etc. He would like for Stanfield Town Council to write a letter to Stanly County Board of Commissioners in support of this proposal.

Ms. Bessie Garmon would like to see the community get involved in the town's meetings.
