Minutes of Regular Meeting for October
on October 6, 2022**

Determination of Quorum

A quorum was determined with the presence of Mayor Pro-Tem James Kluttz and Commissioners Jerry Williams, Faye Love, Greg Bratton, and Brent Holbrooks.

Jerry Williams made a motion to excuse Kevin Barbee. All were in favor. Motion carried.

Call to Order

Approval of Agenda

Parks & Recreation

We have received plans from engineering for the concession and bathroom remodel at Pete Henkel Park. Stanly County has approved these plans. We will be running this in the newspaper for bids. We are still waiting on engineering plans for the retaining wall plans at ballfield # 1. Once we receive these, we will put this out for bids.

Water & Sewer

Sewer line burst at the intersection Big Lick and Elm St. Our maintenance guys had to work with Locust/Stanly Co folks to help get this repaired. Water and sewer are officially on at Park View Development.

Planning & Zoning

Nothing at this time.

Mayor

Annual leaf pick-up will be on November 19 and December 17. Stanfield residents can drop off limbs at Pete Henkel Park first 2 weeks in October.

Public Comment

Bobbie Sedberry- Why leave the ditch on Hwy 200 open? If sidewalks go in, the ditch needs to go away.

Phyllis Barnette- The western end needs more EMS trucks, and we need a new fire department. This needs to be taken to Stanly County Management to check and see if this will happen. It was mentioned that a new fire department will be going in at Renee Ford and River Rd.

Alex Kornivskiy – would like to see the sidewalk go in but had concerns going in correctly.
